Hooch Debate – Rules, Travel, and Release Agreement (1/2)

The signature below indicates that:

I (we) give consent for this student to participate in the Chattahoochee High School Debate Program.

I (we) give consent for this student to travel to all local and out-of-town events.

I (we) hereby agree to release Chattahoochee High School, the Fulton County Board of Education, CHS employees, the CHS Debate Parent Board, and all debate coaches & chaperones from, and will not hold such parties responsible for, any claims, demands, liabilities and causes of action arising out of, or connected to personal injury, illness, death, or property damage resulting from participation on the Chattahoochee High School Debate Team.

I (we) agree to indemnify, defend and hold harmless the above named from any claims, liabilities, costs or expenses arising out of personal injury or property damage that my child causes or contributes to while participating in this program.

I (we) give permission for this student to be driven to and from school sites during the school day and/or to school or debate-related practices, events, activities, or sites after school hours or on the weekend. Either my designated driver or I will be transporting the student to and/or from the event or activity. Either my designated driver or I will present myself to the coach or chaperone after the event or activity has been completed in order to verify the intent to transport the student. I (we) understand that the student cannot be driven to or from a debate-related activity with a different driver.

I (we) give permission for this student to be driven by a parent volunteer and agree to release, indemnify, and hold harmless the Fulton County School System, its Board of Education, its employees, and all Hooch Debate coaches and chaperones from any liability for damages or injuries in the event of an accident caused by such driver.

I (we) agree to hold Chattahoochee High School, the Fulton County Board of Education, CHS employees, the CHS Debate Parent Board, and all Hooch Debate coaches and chaperones harmless in the event of injury to this student, including any property damage, while the student is driving or being driven to or from a school site and/or to school or debate-related events, activities, or sites during or after school hours.

I (we) understand that students sign-up for tournaments by putting their name on lists in the debate room. I (we) understand that if my student puts their name on a tournament list, that that is an indication of their interest and intent to attend the tournament. I (we) understand that if my student is then unable to attend that I (we) may be held responsible for any financial costs incurred by the team in securing the student's spot including, but not limited to: registration fees, hotel fees, transportation fees, judges fees, etc. for my student and his/her debate partner. I (we) understand that this includes inability to attend due to other extra or co-curricular events, family commitments, schoolwork, or other obligations as it is our family's responsibility to determine these matters before the sign-up deadline.

I (we) understand that Chattahoochee Debate coaches and chaperones have the right to make changes to any debate activity program, logistics, or arrangements for the safety, comfort, or convenience of members of the group whenever in the sole judgment of the coaches and/or chaperones such changes are deemed necessary. I (we) understand that no responsibility or liability is incurred by the coaches and/or chaperones for any loss or damage resulting from or related to such changes.

I (we) hereby give permission to coaches and chaperones of the Chattahoochee High School Debate Team to secure medical care for my child in the instance of an emergency. In the event of an emergency, coaches and chaperones are given permission to act on my (our) behalf in administering or seeking medical attention.

Hooch Debate – Rules, Travel, and Release Agreement (2/2)
